# **Indigent Defense Updates**

### **DOJ Public Defense Resources Hub**

DOJ Access to Justice launched the <u>Public Defense Resource Hub (the "PD Hub"</u>), a one-stop destination of federal resources and materials to support public defense. The Hub will collect existing resources for professionals providing public defense services, public defense commissions, and policymakers and host new tools to help defenders access resources, research, and guidance to support the constitutional right to counsel.

## Applications open for BJA's 'Postconviction Testing of DNA Evidence' (Federal Grant)

This opportunity seeks to assist in defraying the costs associated with postconviction case review, evidence location, and DNA testing in violent felony cases (as defined by state law) where the results of such testing might show actual innocence. Grant activities can include: identifying potential postconviction DNA testing cases, reviewing appropriate postconviction cases to identify those in which DNA testing could prove the actual innocence of a person convicted of a violent felony offense as defined by state law, locating biological evidence associated with such postconviction cases and performing DNA analysis. **The deadline for submission on grants.gov is April 29.** There is an informational webinar on April 3, Register to participate. # Applications open for BJA's 'Justice and Mental Health Collaboration Program' (Federal Grant)

This opportunity supports cross-system collaboration to improve outcomes for individuals with mental health disorders (MHDs) or co-occurring mental health and substance use disorders (MHSUDs) in the criminal legal system. The grant focuses on addressing the needs directly related to adults with mental health conditions, living in homelessness or marginalized communities with minimal access to treatment, needing wrap around services who are in the criminal legal system. Note that BJA will only accept applications that demonstrate the proposed program will be administered jointly by an agency with responsibility for criminal or juvenile justice activities and a mental health agency. **The deadline for submission on grants.gov is May 9.** There is an informational webinar on March 19, Register to participate. # **Research Opportunity**

Pregnancy Justice, the leading legal nonprofit addressing pregnancy criminalization, is <u>tracking Post-Dobbs</u> instances where an individual's pregnancy was a but-for factor in their arrest or justification for a criminal penalty (i.e., pregnancy-related arrests or penalties occurring on or after June 24, 2022). This research is inclusive of people facing charges related to all pregnancy outcomes (live births, stillbirths, miscarriages, abortions) or for any behavior that authorities believe puts a pregnancy at risk. 

# People v. Renteria: How to Get Your Lone Actor Client Retroactive Relief in Gang Cases

People v. Renteria (2022) 13 Cal.5th 951 clarified and narrowed the requirements necessary to prove gang enhancements against lone actors. Last year OSPD attorneys filed a habeas petition arguing for retroactive application of Renteria to a final case and won relief for their client. In this webinar, those attorneys will discuss Renteria's application to lone actor cases and cases involving defendants with unknown or non-gang affiliated coparticipants, and the theory of retroactivity making Renteria applicable to final cases. They will also provide you with a model petition, walk through how to complete and file the petition for your own lone actor client, and discuss further proceedings in the trial court. OSPD is also looking for several cases to handle in-house and will share contact info to discuss potential cases prior to the Q & A.

# Public Service Loan Forgiveness: New Rules for Panel & Contract Lawyers

The federal Public Service Loan Forgiveness (PSLF) program allows qualifying federal student loans to be forgiven after 10 years of qualifying payments made while working for a qualifying public service employer. Recent changes to the PSLF program regulations expanded the definition of "qualifying employment" for purposes of loan forgiveness. OSPD cannot offer legal advice about this federal program, however, this webinar will provide our understanding of how these changes may apply to contract and panel attorneys who provide indigent defense outside of institutional public defender offices. It will also highlight programs from other places that have used the changes in the PSLF program regulations to benefit their contract and panel attorneys.
