The Eugenic History of California's Three Strikes Law

Did you know that "habitual offender" laws originated in the early 1900s as part of the eugenics movement? Associate Professor Daniel Loehr has conducted extensive research into the history of such laws, including the pseudoscience on which they were based. In his writing, Prof. Loehr explains how current Three Strikes laws are part of the legacy of racist beliefs that crime has a biological basis. In this webinar, Prof. Loehr will share his findings and well as ideas on how to use this history to support RJA claims at the trial and appellate level, *Romero* motions, and other challenges to Three Strikes sentencing.

During this webinar, Megan Leschak, LMSW, will discuss common causes and symptoms of psychological trauma including interpersonal, environmental, and social engineered forms of stress. Additionally, Megan will invite attendees to explore ways to gather trauma histories to reduce harm to selves and promote healing on teams.
