This webinar offers a practical introduction to CARE Court for public defenders not directly involved in the process. Participants will gain a clear understanding of what CARE Court is—and isn't—particularly in contrast to mental health diversion programs and other judicial behavioral health interventions. The session will cover how CARE Court intersects with other court proceedings, including criminal competency issues and LPS conservatorship step-downs. We will highlight key risks such as potential conservatorship and immigration consequences. Attendees will also explore how to maintain confidentiality, recognize waiver risks, and navigate communication between attorneys when clients are served by different branches or offices. Through legal overview and real-world discussion, defenders will be better equipped to advise clients and collaborate effectively with CARE Court counsel.

Public defenders frequently represent clients whose criminal cases involve potential civil rights violations. This webinar offers a practical framework for identifying and preserving those claims to support greater police accountability. Presenters will outline key distinctions between civil and criminal practice, discuss how procedural hurdles—such as plea agreements and statutes of limitations—can impact civil rights claims, and share strategies for navigating the criminal case in ways that help protect a client's ability to seek justice in the civil arena. This webinar will explore the mechanisms of the relief granted by the Safer Streets for All Act (SB 357), which decriminalized "loitering for the purpose of prostitution" and other prostitution related activities. Attendees will gain understanding of the decriminalization of sex work through SB 357, learn models used by public defender offices that have successfully pursued mass relief under PC 653.29, and review the motion process. The session will also address the immigration consequences of convictions for "loitering for the purpose of prostitution" (PC 653.22) and discuss more effective relief methods for non-citizen clients. Finally, the webinar highlights additional forms of relief available for individuals whose convictions may be connected to human trafficking. *1 hour of MCLE and Legal Specialization Credit in Other Subjects Related to Criminal Law is offered for this training*

Crisis Debriefings for Public Defenders

Defenders in all job roles are invited to join this session to learn about debriefing as a tool to process defense experiences. As public defenders, we work with people at some of the most difficult times of their lives. Our work involves navigating moments of crisis, such as: difficult case outcomes and harm to the people we represent; traumatic experiences of ourselves and our colleagues; and larger crises such as wildfire, flood or pandemic. As social worker and trauma exposure researcher Laura van Dernoot Lipsky reminds us, it is critical to "metabolize all that we

are experiencing" in the course of our work. In this session, social workers Marisa Beckley and Caitlin Becker will discuss a model for holding structured "crisis debriefings" in public defender offices. Attendees will increase their awareness and understanding of the debriefing model as one way to help all defense teams metabolize experiences of crisis.
